A proposal for modifying the amendment in the regulation of B.Sc. – M.Sc. (Integrated) Biotechnology course was placed in the 62^{nd} meeting of the Board of Studies (Faculty of Agriculture) held on 07.11.2019 and the board has approved the following amendments.

34(i), 107	A candidate who fails in the comprehensive examination shall be permitted to appear for the examination for a second time after a minimum period of four months.	Approved as "A candidate who fails in the comprehensive written/ viva voce examination shall be permitted three attempts to appear for the supplementary with a minimum interval of two months".
34(j), 107	A candidate who fails in a\the comprehensive examination in his/her second attempt will not be allowed to continue the programme or to take any further examinations, and his/her name shall be removed from the rolls	Approved for deleting the clause.
