As per the report of the internal marks received vide reference cited 2<sup>nd</sup>, the semester examination results of the students appeared for III Semester Final Examination, 2016 Admission of B Sc. (Hons. )Ag. Degree Programme, College of Agriculture, Vellayani was notified. But the result of the student **Lakshmi Krishna** .**T.G** ( **2016-41-330**) was withheld due to the discrepancy in her Register number , which was identified during the centralized evaluation.

After publication of the results, the Academic Officer, College of Agriculture, Vellayani reported through the Dean (Agri) that a discrepancy occurred while allotment of the Register Number to the student from the College, since the student was transferred from CoA, Padannakkad to CoA, Vellayani in the vacant seat of another student whose register number was 2016-41-170. The College authorities allotted 2016-41-170 as register number to the student Lakshmi Krishna .T.G (2016-41-330), but the student has already completed her two semesters with Reg.No 2016-41-330, which was her original register number alloted at the time of admission at CoA, Padannakkad. The student has written all the examinations (11 courses ) of III semester with the register No. 2016-41-170 which was allotted by the college instead of her original register number, 2016-41-330 and submitted the answer books to the university for evaluation. At the time of the evaluation, this discrepancy was noticed at the university and an explanation was sought from the Dean. Vide ref. (4) cited, the Dean has offered remarks and admitted that a discrepancy has occurred in the academic cell of the college and they corrected the details accordingly when identified the error and re-submitted the internal marks. In response to the letter vide ref. cited (5) above, the Dean has submitted necessary certificates and corrections vide letter cited 6<sup>th</sup> requested to notify the withheld result of the student Lakshmi Krishna .T.G ( 2016-41-330).



As per the request vide ref.(6)cited, and the orders of the Hon. Vice Chancellor vide ref. cited as (7), the withheld results of the student **Lakshmi Krishna**.**T.G** ( **2016-41-330**) for eleven courses of her III semester is hereby notified. The result notification vide ref. cited 3<sup>rd</sup> is modified with this effect. All other results in the notification referred vide ref. (3) cited stands as such. Tabulated sheets and grade reports are also appended herewith.

Since, it is a withheld result notification, last date of receipt of application for revaluation if any with fee at the college office should be within 15 (fifteen) days from the date of this notification, and the application for revaluation should be reached to the university within 7 (seven) days from the last date of receipt of application for revaluation at the college.
