- i. Processed rice seed lots (~200365.00 kg) of rice variety KAU Manu Ratna that have lost germination (Germination < 80%) *i.e.*, non-germinating seeds (NGS) is available for disposable at the Seed Processing Godown located near the KAU school premises, within the campus.
- ii. The seed lots offered for disposal was harvested during Rabi 2022-2023 between 24th January, 2023 and 22nd March, 2023 and had been packed and stored in intact bags of 30 kg.
- iii. The moisture content of NGS lots is ≤ 13 to 15 per cent.

- iv. The lots were winnowed thoroughly before bagging such that the physical impurities (chaffs/ bits of straw and seed husk/ stones/ mudballs/ awns/ other plant parts etc) are less than 2.00 per cent (\leq 2.00%) before packing bagged (30 ± 0.2 kg per bag) in the printed gunny bags.
- v. The filled bags had been stitched properly such that there is no loss of seed during handling of the seed bags. However, a few bags may be damaged in due course during the storage.
